The notice will provide the address of the internet web site or other location where the disclosure or revised disclosure has been made available. Disclosures, notices and monthly account statements will be made available on the Online Banking website for at least 90 days after you are notified.

It is your responsibility to provide us with an accurate and complete e-mail address, contact and other information related to this disclosure and your account, and to maintain and promptly update any changes in this information. ## **System Requirements to Access Information**

To receive an electronic copy of the disclosures, notices, terms and conditions, monthly account statements and other documents about your account, you must have the following equipment and software:

- A personal computer or other device which is capable of accessing the internet. Your access to this page verifies that your system/device meets this requirement.
- An internet web browser that is capable of supporting 128-bit SSL encrypted communications, such as
  Microsoft Internet Explorer version 6.0 or above. Your access to this page verifies that your browser and
  encryption software/device meet this requirement.
- You must have software which permits you to receive and access Portable Document Format or "PDF" files, such as Adobe Acrobat Reader version 7.0 or higher.
